Johnny Wactor, o ator mais conhecido por seu papel na novela General Hospital morreu após ser baleado e morto durante 3 um suposto roubo apostas nacionais Los Angeles. Ele tinha 37 anos de idade

O departamento de polícia mais tarde confirmou que Wactor 3 foi baleado por volta das 3h da manhã do sábado, depois confrontando três homens supostamente tentando roubar o conversor catalítico.

A 3 polícia foi chamada e Wactor levado para um hospital local, onde ele estava morto.

Os suspeitos fugiram da cena apostas nacionais um 3 veículo e não foram presos, disse a polícia.

A investigação continua

O agente de Wactor, David Shaul também confirmou apostas nacionais morte 3 à Variety.

"Johnny wator foi um ser humano espetacular", escreveu apostas nacionais comunicado: "Não apenas o talentoso ator que estava comprometido 3 com seu ofício mas sim como verdadeiro exemplo moral para todos os seus conhecidos e pessoas interessadas no trabalho duro; 3 tenacidades nunca desistem da atitude".

Ele descreveu o trabalho com Wactor como um privilégio: "Ele literalmente lhe daria a camisa das 3 costas. Depois de mais uma década juntos, ele deixará algum buraco apostas nacionais nossos corações para sempre."

Wactor nasceu apostas nacionais 1986, na 3 cidade de Charleston (Carolina do Sul), e seu primeiro papel foi no drama da série Lifetime Army Wives. Ele passou 3 a aparecer como convidado para vários papéis nos programas Westworld The OATM Criminal Minds TM

De 2024 a 2024, Wactor 3 apareceu apostas nacionais mais de 160 episódios do Hospital Geral.

O Hospital Geral emitiu uma declaração no domingo: "Toda a família do 3 hospital geral está de coração partido ao ouvir falar da morte prematura Johnny Wactor. Ele foi verdadeiramente um tipo e 3 prazer trabalhar com todos os dias, nossos pensamentos ou orações vão para seus amados durante este momento difícil."

Ele é sobrevivido 3 por apostas nacionais mãe, Scarlett e seus irmãos Lance and Grant.
