## **3. betscasino :pixbet aposta futebol**

A família de Jessie Peterson passou um ano procurando por ela depois que eles foram informados da betscasino própria saída do hospital na Califórnia, contra aconselhamento médico – antes deles descobrirem o tempo todo.

A 31-year-old man, died in the care of the Mercy San Juan hospital in Sacramento in April 2024. The hospital sent his body to a storage facility and did not inform his mother or sisters about his death until the following month. After several months of trying to find out what happened, the family filed a civil lawsuit against the hospital.

In the lawsuit, filed at the beginning of this month, the family described the hospital's behavior as "malicious and outrageous" and accused the hospital of negligence in front of the family.

"The Mercy San Juan hospital failed its most fundamental duty to notify the family of its son's death," says the lawsuit.

Jessie Peterson, the mother of the deceased, was left to decompose for nearly a year, while the family tirelessly searched for his remains. Peterson, whom the lawsuit describes as "loving and energetic", had type 1 diabetes. She was suffering from a diabetic episode when she was admitted to Mercy San Juan on April 6, 2024. Her mother, Ginger Congi, said she had been waiting for two days for her son to be discharged from the hospital, according to the lawsuit.

Congi was informed much later that Peterson had left the hospital against medical advice, and her medical records indicate she was discharged on April 8. After his sudden disappearance, the family became "desperate" in searching for his wife - posting flyers to talk to neighbors in the area - entering the police station or the lawyer's office to file lawsuits.

On April 12, 2024, more than a year after Peterson was last seen in the lawyer's office, the Sacramento County sheriff's office informed the family that his body had been found dead at Mercy San Juan. According to the lawsuit, Peterson's death (which was concluded in April 2024) was caused by a heart and lung condition at the age of 31.

The mother of Peterson went to the lawyer's office to retrieve his remains, but a worker told her that the body was not there and directed her to contact the hospital. Mercy San Juan was unresponsive to the family's requests for answers; a funeral home ended up informing Congi that his son's body was found in an external storage unit at the hospital where he was staying.

His body was so decomposed that the family could not get digital impressions or hold a funeral with an open casket, and an autopsy would have indicated if there had been medical negligence associated with his death, according to the lawsuit.

"The failure of the defendants to issue a death certificate, the lack of notification to the next of kin, Jessie Peterson, the omission to allow an autopsy and poor handling [was] negligent," says the lawsuit. "The defendants violated their own promise of dignity and respect for the people in their care." The lawsuit says the defendants' conduct is "so heinous that the damages should be awarded."

The family is seeking more than \$5 million in damages, as well as "five times the amount of the jury's verdict in punitive damages for the defendants' outrageous and indefensible" and attorney's fees.

A Dignity Health, which operates Mercy San Juan, issued a statement: "We extend our deepest condolences to the family during this difficult time. We cannot comment on pending litigation."
