Ex-presidente dos EUA, Donald Trump, faz discurso caught up bet next episode release date Arizona após debate com Kamala Harris

Donald Trump fez seu primeiro discurso público desde o debate contra Kamala Harris caught up bet next episode release date um evento de campanha no Arizona, um estado-chave que ambos os candidatos desejam garantir.

Estimava-se que 5.000 pessoas enfrentassem as temperaturas abrasivas - que permaneceram acima de 100F (37,8C) durante a tarde - enquanto aguardavam caught up bet next episode release date fila do lado de fora do Linda Ronstadt Music Hall caught up bet next episode release date Tucson, um auditório alugado pela campanha que comporta cerca de 2.300 pessoas. Enquanto isso, equipes de emergência da cidade responderam a diversas chamadas de lesões causadas pelo calor antes de Trump subir ao palco, de acordo com a repórter da rádio pública local Alisa Zaira Reznick.

Trump se foca caught up bet next episode release date recontar seu desempenho no debate

Trump discursou diante de um fundo com suas promessas de campanha "tornar o habitat acessível novamente" e "nenhum imposto sobre gorjetas" - um sinal de que o discurso se concentraria caught up bet next episode release date ampliar seu plano econômico. No entanto, o ex-presidente usou a maior parte de seu tempo para recontar seu desempenho no debate, retratando-o de uma forma muito mais favorável.

"Nós tivemos uma vitória monumental sobre a camarada Kamala Harris", disse Trump aos aplausos, usando um apelido depreciativo e pronunciando intencionalmente o primeiro nome da vice-presidente de forma incorreta. Sua descrição contrastava fortemente com a crítica generalizada sobre caught up bet next episode release date atuação, que até mesmo assessores de Trump admitem não lhe trará votos novos.

"Defenderemos a segunda emenda, restauraremos a liberdade de expressão e garantiremos nossas eleições. Todos prosperarão, todas as famílias florescerão e todos os dias estarão repletos de alegria e oportunidade e esperança", disse Trump, pedindo a caught up bet next episode release date base que lhe dê uma vitória aterradora que seja "tanto grande que não possa ser manipulada".

O Arizona é um estado de batalha caught up bet next episode release date que as campanhas Trump e Harris têm dedicado atenção este ``less semana. O segundo gentio, Doug Emhoff, também estava programado para visitar Tucson, um enclave democrata inclinado, na quinta-feira.

A campanha Trump foi obrigada a pagar um depósito de R\$145.222,70 para o uso do auditório e dos policiais locais que iriam realizar serviços de segurança no evento, uma política estabelecida pela cidade após o ex-presidente não ter pago uma conta de R\$80.000 por um comício realizado lá caught up bet next episode release date 2024.

"Aprendemos nossa lição", disse o vereador de Tucson Kevin Dahl ao Arizona Daily Star,

acrescentando que a cidade escreveu a dívida.

Linda Ronstadt, a cantora para quem o local é nomeado, divulgou uma declaração às quartas-feiras condenando o ex-presidente e expressando seu apoio a Harris.

"Não apenas me desprezo por caught up bet next episode release date política tóxica, seu ódio às mulheres, imigrantes e pessoas de cor, caught up bet next episode release date criminalidade, desonestidade e ignorância", disse ela, expressando caught up bet next episode release date tristeza por ele ter trazido seu "show de ódio" para Tucson.
